- Contributions to the LeadingAge PA PAC are not charitable contributions for federal income tax purposes.
- According to state campaign laws, only individuals and other political action committees are permitted to contribute to the LeadingAge PA PAC.
- State laws require political committees to collect and report the name, the mail address for the credit card or check, employer, and occupation of individuals who contribute in a calendar year based on the contribution amount.
