Executive Summary

RKL LLP (RKL) prepared a Pennsylvania (PA) Medicaid (MA) Funding Gap Analysis of nursing homes in PA for LeadingAge PA (LAPA). The analysis compared the shortfall between MA reimbursement and actual costs of care. Based on our analysis, the PA MA funding gap for nursing facilities statewide results in a total shortfall of \$1,164,784,000, or \$86.26 per resident day.

The chart below summarizes the results and shortfall for the 2022 analysis compared to the analysis we prepared in 2019.

The PA Statewide results are based on the reported expense data of 595 nursing homes that submitted full year MA cost reports (Form MA-11, Financial and Statistical Report for Nursing Facilities and Services Under the Medical Assistance Program of the Department of Human Services Commonwealth of Pennsylvania), which were posted publicly as of January 6, 2022. We calculated the MA revenue based on publically posted revenue data and occupancy presented within the MA-11 Cost Reports.

Overview

RKL LLP (RKL) prepared a Pennsylvania (PA) Medicaid (MA) Funding Gap Analysis of nursing homes in PA for LeadingAge PA (LAPA). The analysis involved updating a database prepared in 2019 using December 31, 2017 and June 30, 2018 data from MA cost reports. This database is utilized to analyze the potential gap between the amount that the MA program reimburses Nursing Facilities (NFs) and the expenses that the NFs incur. The complete list of NFs included in the database is contained in **Appendix 1**.

We included all MA payments to determine the total MA reimbursement. The sources of data included the daily MA reimbursement rates and supplemental revenue schedules published by the PA Department of Human Services (DHS). For expenses, we utilized actual expenses reported on the annual MA cost reports (Form MA-11, Financial and Statistical Report for Nursing Facilities and Services Under the Medical Assistance Program of the Department of Human Services Commonwealth of Pennsylvania) that are publically available from DHS on the website https://nfrp.panfsubmit.com/. The fiscal year ends for all MA cost reports were December 31, 2020 or June 30, 2020.

Highlights of the Analysis

Based on our analysis, the PA MA funding gap for nursing facilities statewide is **\$86.26 per resident day** as follows:

Development of the Database

RKL utilized the MA-11 Cost Reports that were available on the DHS website as of January 6, 2022. In addition, we utilized only full year cost reports, which totaled 595 NFs. Of these, there were 376 cost reports with a December 31, 2020 year end and 219 cost reports with a June 30, 2020 year end.

For each cost report, we utilized the actual expense data as reported on the MA-11, Schedule C "Computation and Allocation of Allowable Costs". We included amounts in columns A-D, which includes Salary Cost (Column A), Fringe Benefits (Column B), Other Expenses (Column C) and Total Expenses (Column D). We included all cost centers for Resident Care, Other Resident Related, and Administration. We also included all of the Capital Costs.

We analyzed the cost report expense data and adjusted expense amounts in order to isolate NF expenses versus Residential expenses. We reduced the NF expenses for each cost center by the percentage of Residential allocations in Schedule C, Column J, if applicable. In addition, if an NF had Residential allocations, we reduced certain Capital Costs by the percentage of Residential square footage to total square footage reported in Schedule I, Question 7 and 7a.

We also adjusted expense amounts for items we considered expenses not associated with NF care and outlier expenses. These adjustments included the following:

- Significant negative expense amounts for Practitioners (adjusted to zero);
- Community Based Services expenses (excluded);

- Wellness Center expenses (excluded);
- Companion Services expenses (excluded);
- Café expenses (excluded);
- Marketing expenses (excluded);
- Unrelated and Other Location expenses (excluded);
- Adult Day Care expenses (excluded); and
- Any expenses listed without a description.

We calculated averages per resident day for each data point using an arithmetic average. The arithmetic average is calculated by adding all of the NFs together and then dividing by the number of NFs.

To determine the deficit that NFs incur by accepting MA residents, we calculated the difference between the MA revenues and the adjusted NF expenses. The process to determine the MA revenues is discussed below.

We calculated the MA revenue by including the following MA reimbursements:

- MA daily rate for room and board (R&B);
- Disproportionate Share Incentive (DSH) payments;
- Healthcare-Associated Infections (HAI) payments;
- Medical Assistance Day One Incentive (MDOI) payments;
- Appendix 4 payments;
- Supplemental Ventilator Care and Tracheostomy Care (Vent) payments; and
- Exceptional Durable Medical Equipment (DME) payments.

The methods and information analyzed for each of these revenue items are described below.

Room and Board Revenue

The room and board MA revenue is separated into two categories: Community Health Choices (CHC) Managed Care Organization (MCO) revenue and other MA revenue. CHC MCO revenue rates are not publically available; however, each facility received a floor rate upon entering into the MCO contract, which is equal to the prior four quarter average of published rates. The floor was calculated utilizing the following periods:

- Southwest Region January 1, 2017; April 1, 2017; July 1, 2017; October 1, 2017
- Southeast Region January 1, 2018; April 1, 2018; July 1, 2018; October 1, 2018
- Northwest, Northeast and Lehigh Capital Region January 1, 2019; April 1, 2019; July 1, 2019;
 October 1, 2019

The quarterly MA rates were based off of the MA rate schedules posted quarterly by DHS. We utilized the MA Rates after the budget adjustment factor (BAF) for each quarter. The MCO rate floor was then multiplied by the amount of CHC reported days. It should be noted that facilities in the Northwest, Northeast and Lehigh Capital Regions with June 30, 2020 year ends would have two quarters (the period of July 1, 2019 through December 31, 2019) with no CHC MCO days. For facilities who opened after the MCO program began in their region, the calculation assumes a MCO floor rate is equal to an average first four quarters that they participated within the program.

While the MCO contracts pay out a majority of the MA room and board amounts, there are situations in which a facility would still receive reimbursement based on the posted quarterly MA rate. This occurs for the time between when a resident is approved within the MA system, but before they have signed with a MCO provider. These resident days are multiplied by the applicable quarterly rates. The quarterly MA rates were based off of the MA rate schedules posted quarterly by DHS. We utilized the MA Rates after the budget adjustment factor (BAF) for each quarter.

Disproportionate Share Incentive Payments (DSH)

The Disproportionate Share Incentive payment revenue was calculated based on remittance dates. The DSH revenue amounts came from the remittance schedules released by DHS. There was one DSH remittance that occurred during the time frame included in this analysis, prior to being discontinued. The remittance date included August 12, 2019. However, DSH payments are paid on an annual basis with calendar year facilities receiving their payments in August, and facilities with a fiscal year end of June 30th receiving their payments in February. Therefore, while we analyzed the August 12, 2019 remittance for inclusion, none of the cost reports we included would have reflected that payment.

Healthcare-Associated Infections Payments (HAI)

Healthcare-Associated Infections payment revenue was calculated based on remittance dates. Similar to DSH payments, the HAI payments are paid annually with calendar year facilities receiving payments in August, and facilities with a fiscal year end of June 30th receiving payment in November. Due to the timing lag, the last year full year that has been processed is 2019, which would be for June 30, 2019 and December 31, 2019 year ends. Since, this is the last full year processed these are the two remittance included and were remitted to the facilities on November 30, 2020 and January 25, 2021 respectively.

Medical Assistance Day One Incentive Payments (MDOI)

MDOI payment revenue was calculated based on remittance dates. MDOI revenue is paid separately for public and nonpublic facilities. The MDOI revenue amounts came from the remittance schedules released by DHS for both the public facilities and the nonpublic facilities. For public facilities, there are payment calculations on a quarterly basis. The remittances included in the calendar year end facilities are as follows: February 3, 2020 for July through September 2016; February 3, 2020 for October through December 2019. There were no MDOI payments posted after February 3, 2020 as the program was discontinued. The nonpublic MDOI payments were adjusted from a quarterly payment schedule to a semi-annual payment schedule beginning for fiscal years ending June 30, 2018. The remittances included are January 20, 2020 and April 6, 2020. It should be noted that there was an adjustment for FY 2018-2019 which was received on a remittance dated September 9, 2019. This adjustment accounts for a total of \$78,128 total, and averaged \$200 and \$400 per facility. This remittance was excluded from the calculation, because it was a prior period adjustment.

Access to Care Payments

When Pennsylvania entered into the CHC program with the three MCOs, Pennsylvania could no longer pay out the allowable cost or supplemental payments directly to nursing facilities for the provider assessment. The Access to Care payments took the place of these payments through Appendix A4.

The payments are made monthly. Payments related to the period July 2019 through December 2020, which would have been remitted September 2019 through February 2021, are included in this report. These payments include IGT payments effective upon transitioning to the MCO structure. Only IGT payments remitted through the Access to Care Program are captured.

Allowable Costs and Supplemental payments are included in FY June 30, 2019 cost reports within the Lehigh Capital Region, Northwest Region, and North East Region as they did not go into the Access to Care A4 program until January 2020.

Supplemental Ventilator Care and Tracheostomy Care Payments

Supplemental Ventilator Care and Tracheostomy Care payment revenue was calculated based on the quarter for the related resident days. The Vent revenue amounts came from the remittance schedules released by DHS. This program was discontinued with Community Health Choices. There were not facilities eligible for these payments during the period examined, as no payments were made on quarters starting after July 1, 2019.

Exceptional Durable Medical Equipment Payments (DME)

Exceptional Durable Medical Equipment payments were calculated based on the MA-11, Schedule D "Revenues and Adjustments to Revenues." The amount utilized is from Schedule D, Column A, "Medical Assistance", Line 10, "Exceptional DME Grant Payments."

COVID-19 Payments

During the timeframe analyzed, the state of Pennsylvania released funds to offset the effects of the COVID-19 pandemic through a program referred to as "Act 24 payments". However, Pennsylvania did not release funds under Act 24 to mitigate COVID-19 until July 1, 2020. Due to the timing of the disbursement, most June 30, 2020 year end facilities would not have considered the Act 24 payments on their cost report. In an effort to ensure that the analysis treated June 30,2020 and December 31, 2020 facilities consistently, we included the Act 24 payments for all facilities, regardless of their fiscal year end.

We did not include Federal Provider Relief COVID-19 Funds (PRF) within the analysis. PRF was excluded because the program was a federally funded program, where as the analysis is focused on the state funded program of Medicaid. Additionally, the PRF funds were distributed on a Tax Identification Number (TIN) basis, which for continuing care retirement communities (CCRCs) would include all levels of care and business lines within the TIN and not just the nursing home. Finally, the exclusion is appropriate as the usage period of the funds extended out past our analysis period, with the earliest usage period ending June 30, 2021. While the required reporting of the first set of PRF funds is complete, the reporting from facilities is not disclosed publically.

Calculations

RKL calculated the Medicaid funding gap using the revenue and expense data noted above. For all calculations, a positive number represents a surplus of revenue and a negative number represents a deficit incurred by the facility for caring for a Medicaid resident.

The Medicaid revenue calculation is based on calculated revenue for each NF. The revenue in this calculation includes all of the Medicaid reimbursement revenue described above. These revenue sources are added together and then divided by the total Medicaid days reported on the cost report. The result is the average Medicaid revenue per Medicaid resident day. The average expense per resident day is then subtracted. This is calculated individually for each NF and provides the Medicaid excess/(shortfall) calculation per resident day.
