Residents and their families need reassurance. Staff members look for stability. And board members need help navigating unprecedented community interest in these times of major transition.

Between heightened scrutiny from outside parties, increased demands for transparency and the rapidly changing world of senior living, boards and board members need to fully understand their responsibilities and be at the top of their game. This session will explore the roles and responsibilities of boards and discuss specific activities that support this work.

Legal and Compliance Considerations for Nonprofit Health Care Board Members Thursday, March 23 | 12:00 – 1:00 pm Presented by Latshaw, Davis & Marshall

Nonprofit health care providers must navigate a complex set of regulations which govern their operations. While day-to-day operations are handled at the management/staff level, it is critical for Board Members to understand the organization's relationships with multiple regulatory agencies and the expectations placed on Board Members by those agencies. Without such an understanding, Board Members cannot successfully fulfill their fiduciary duties to the organization and provide appropriate direction. In this session, the presenters will first review nonprofit healthcare provider obligations under IRS rules, so that the Board can ensure that the entity maintains its exemption from federal taxes. The session will next review the state and federal licensure, regulatory and certification requirements imposed upon post-acute providers, with which all Board Members should be familiar. The presentation will then review the fraud and abuse compliance requirements imposed on providers, the Board's role in developing appropriate compliance plans for the organization, and the Board's oversight responsibilities with respect to the activities of the management team to ensure compliance. Finally, the session will provide "real life" examples of how these issues should be reviewed and resolved by the organization's Board.
