# HCBS

- **CMS will end gap billing between hospice transfers** Beginning in July, Medicare Administrative Contractors (MACs) will have new system edits to prevent gap billing between hospice transfers. Since hospice transfers must occur on the same day, there cannot be a break in hospice care or a gap in billing. The Medicare Learning Network (MLN) provided an <u>article</u> explaining the reason for the change request and expectations for hospices.
- **Community spread threshold rate guidance for adult day care and LIFE providers** Please monitor <u>community spread threshold rates</u> carefully as rates continue to increase. Providers should review and proceed with mitigation policies, if necessary. DHS also reminds facilities of several <u>safety precautions</u>.
